The Nursing section was audited and got rave reviews. The Intermediate Care section got systemic improvements in key areas and is expected to be recertified and accepting admissions, perhaps by the time you read this newsletter.

The cheap and distorted hits by King TV, a discredit to television feature coverage, resulted in our recruitment of super high quality FoF board recruits, including our new treasurer Tom Norton [his Great Dane is an ad-

KING 5 Slams Fircrest School and other RHCs

A KING 5 news series called "The Last of the Institutions" paints our states RHC system and Fircrest School as antiquated, expensive and cruel. In each episode reporter Susannah Frame shows old buildings and chain link fences to propel the viewer to a bygone era.

She seems not to know that there is a broad spectrum of need among people with developmental disabilities. Most live at home or with others in a house or apartment. A few, about 4%, require closer care in one of our RHCs; what she calls, "The Last of the Institutions."

They are not, as KING 5 portrays, fenced in. There are no large dormitories or big buildings to live in, and no one is isolated. There are doctors, nurses, therapists and caregivers on duty at all times. Best of all, it costs no more to provide campus based service than it does for community provided services. DSHS has agreed with this, where close care is needed. Even the United States Supreme Court agrees (Olmstead Decision, 1999)

Several years ago we replaced the so called institutions with community homes where some of the folks interviewed by Frame, now live. They are happy to be on their own. But for those who need more intensive care, we built homes on our RHC campuses with individual bedrooms, kitchens and other amenities, much like a house on any American street. These

amenities are difficult-if not impossible - to duplicate elsewhere.

Instead of having KING 5 degrade the RHCs they should be thankful that we have them. Not all states are so fortunate.

Action DD Achieves Most Goals in 2016 Legislature

Action DD sponsored a legislative reception and membership meeting on Capitol Campus February second that doubled the attendance of last year. A packed meeting saw several legislators and members of their staff stop by to take part in the day-long event with members of Action DD.

The high light of the meeting was the showing of the our new video, "Protecting Our Most Vulnerable."

Our legislative objective was to keep the Yakima Valley School open and fund it's respite program, eliminate the discriminatory age limit for RHC admittance from 21 years of age to 18, and get unannounced visits to protect people in community based homes.

Of that, we got 8 respite beds

funded at YVS, and provisions for unannounced visits to community homes. Our bill to save the YVS failed to get through the session. We will pick it up again next year. YVS remains on track to close by attrition when the population sinks to 16 residents.

Action DD's annual elections meeting will be at the Yakima Valley School June 4th, 2016. (details at: <u>actiondd.org</u>) This is an open meeting for all who wish to attend. Please consider being an officer or being on our board of directors.

President Paul Strand is retiring. So far no one has come forward to fill that position. This volunteer opportunity to serve must be filled. The payment for service is knowing that you have helped preserve a system of care that persists in our state only because people like you have given your time and resources for the benefit of all of us.

Fircrest Gets New Superintendent

Megan DeSmet has accepted the position of Probationary Superintendent of Fircrest School. She has been with DSHS for many years serving at the Frances Haddon Morgan Center and Rainier School.

Acting superintendent, Jeff Flesner will leave Fircrest for a new assignment at Rainier School April 22nd. He will fill the position of Assistant Superintendent. In an email he said, "Everyone here, FOF included, has been so very good to me and I do really love it here but the distance is just too much." He lives much closer to Rainier.

OTHER NEWS

Chicago host to nationwide "Together for Choice" Conference

People from all over the country went to Chicago in October to speak up for various facilities which assist the disabled population. Many of them are worried that dollars may dry up over outdated ideas.

Residents of Fircrest School already find themselves at the center of growing controversy with KING 5 news taking aim at what they call the "Last of the Institutions." Some advocates for people with intellectual and physical disabilities are worried about what they call a "disturbing trend" in federal funding. They say that n recent years, the emphasis has been on expanding so-called standalone residential housing for clients at the possible expense of large campus facilities like Fircrest..

"If the government rules that services that we provide are inadequate and everyone must be out in the community, I feel it's ridiculous,

not only the loss of many agencies but the residents involved would definitely be injured by it," said Sister Rosemary Connelly, executive director, Misericordia Heart of Mercy, Chicago.

She fears looming regulation changes and funding recommendations, which she says are fueled by "memories of a time when many large facilities were simply warehouses for people with disabilities."

"That's where the trend began, in opposition to those big, neglectful institutions that were typical of the past. They are not looking at what's available at present," Connelly said.

That's the message behind the Together for Choice Conference.

Disability advocates and representatives from 25 states who want to make sure people continue to have a choice in the types of facilities which are available to their loved ones.



"It's giving us the opportunity to pull together many like minds, people that are providing excellent services whether it's a campus setting, a farm setting, individual homes in the community, whatever it is as long as it's for the people that we serve," said Geana Connelly, Misericordia administrator.

The people at the conference say they just want legislators to remember that the primary concern should be the quality of care, not the size of the facility
