Seventeen Years of the Olmstead Decision

Condensed from VOR.net — Recently, the Department of Justice (DOJ), and the Administration for Community Living (ACL) issued press releases celebrating the 17th Anniversary of the Olmstead decision.

There is much to celebrate in opening doors to community living for people with intellectual and developmental disabilities who can and want to take advantage of its opportunities. Unfortunately, ideological preoccupations with Olmstead's community integration clause, is at odds with that of other choices. The inaccurate application of the plain language of Olmstead has reduced options for all people with I/DD.

By insisting that all people with I/DD live and work in the community, the DOJ and ACL are treating people with I/DD as a monolithic group, not as the individuals they are.

DOJ and ACL are substituting the wishes of the government for that of the person with I/DD or their legal guardian.

While DOJ and ACL policies have opened doors for the less severely disabled, they closed important doors for the more severely disabled. Many of these individuals have lifelong needs that require a very high level of care, the kind often found only in public and private Intermediate Care Facilities, sheltered workshops, and facility-based day programs.

DOJ and ACL are pursuing this agenda in the name of the ADA and Olmstead, but that is not what the ADA and Olmstead call for. Both the statute and the Supreme Court case embody the best values of American society — nondiscrimination and choice. Civil rights laws do not tell people where they must live or work. They guarantee individuals are not denied opportunities based on a particular factor, and they expand choices for individuals who have suffered discrimination. In sharp contrast, DOJ and ACL are using federal dollars to bring lawsuits and promote policies that needlessly and dangerously eliminate important options.

In pursuing its one-size-fits-all ideology, DOJ and ACL are ignoring the vital rights of choice embodied in the ADA itself. Here is what the Court says in Olmstead: "We emphasize that nothing in the ADA or its implementing regulations condones termination of institutional settings for persons unable to handle or benefit from community settings ... Nor is there any federal requirement that community-based treatment be imposed on patients who do

not desire it." Olmstead v. L.C., 527 U.S. 581, 601-602 (1999).

In fact, the Court specifically incorporated the right of choice: "(b) the transfer from institutional care to a less restrictive setting is not opposed by the affected individual," Olmstead, at 587.

Even the DOJ and ACL concept of what constitutes the most integrated setting contradicts the view of Justice Ginsburg:, who wrote: "For some individuals, no placement outside the institution may ever be appropriate. ... Each disabled person is entitled to treatment in the most integrated setting possible for that person – recognizing on a case-by-case basis, that setting may be an institution." Olmstead, at 605.

Not only are DOJ and ACL ignoring the plain language of governing law and decision, they are ignoring the harmful effects of their own policies. Journalists have time and again documented the high rates of abuse and mortality for our most disabled citizens who have been forced out of congregate care facilities into unprepared communities. Federal agencies should stop dictating the lives of the severely disabled, and instead, join hands with the community of individuals with I/DD to ensure that all people with I/DD receive quality services and supports wherever they choose to reside and work.

Friends of Fircrest Must Be Politically Involved

It's only because of the Washington State Legislature that Fircrest and the rest of our RHCs remain open. Just last year King 5 news aired episodes of anti RHC reporting. Several advocacy groups perpetually ask for our closure.

The Yakima Valley School is already scheduled to close. The Morgan Center and Overlake have already closed. These slow dominoes of closure can topple Fircrest and the rest of our RHCs unless we remain active to stop it. The only reason we have Fircrest today is because some legislators understand the need for RHCs.

What can one person do? We can contact our legislators and tell them why we need Fircrest. This personal contact is most important because legislators want to do what their constituency is interested in — that's you. One can also give financial and membership support to Action DD and attend their annual Legislative reception in Olympia. Message From Our President

Dear Friends of Fircrest,

As we advocate for people with developmental disabilities our most important asset is the truth of what we claim to be true. This is why facility tours at Fircrest were so valuable in convincing legislators to keep it open. Seeing is believing and the tours discredited closure advocate claims and revealed our truth.

Reputation for credibility takes time and effort to establish and can be easily damaged with false reporting. Restoring a reputation is far more difficult than harming it, so it is vital that we do our very best to ensure the accuracy of our claims. We can fairly draw different conclusions or opinions from facts, but facts are facts whether or not convenient to support our opinions.

We can expect adversaries to have different opinions and even to dispute factual matters. Our internal discussions should be lively, truth searching, and focused on furthering our mission. But what about our friends? To paraphrase Warren G. Harding: "I have no trouble with my enemies. But my damn friends, they're the ones who keep me walking the floor nights."

While we, as advocates, may be annoyed by false accusations in the moment, the real harm devolves upon those we work to protect. In our world the victims of advocate in-fighting are vulnerable people with developmental disabilities. If advocates lose credibility the cause they champion is hurt. This is not to say that we can't disagree amongst ourselves. But we should be circumspect about public pronouncements and be especially careful that our public commentary has solid factual bases.

This issue came to mind when I read a blog that claimed Friends of Fircrest [identified but not named] "didn't care" [paraphrasing] about "any standards" [actual quote] at Fircrest. I found this claim surprising not only because it is not true but also because I was identified as the source of the claim. The writer is entitled to her own opinion but not her own "facts." I assume this was meant to annoy me and/or Friends of Fircrest. And, yes it's annoying. And I'll get over it personally. But the real harm inures those whom the blogger wants to help as well.

I've found members of FoF to be extraordinary people with a deep sense of dedication to others who are most

vulnerable. I've found FoF to be an extraordinary just and selfless group, dedicated to fair play. For nearly twenty years I have been heartened by the scrupulous dedication to truth among RHC advocates. I find it most unfortunate that a friend would so easily and carelessly [and falsely] disparage this remarkable group of dedicated souls.

So with a bit of empathy for former president Warren G. Harding and total dedication to the truth, let's keep the faith and advocate on...
